# MEET THE NEW SECRETARY-GENERAL OF THE COMMONWEALTH



On 1 April 2025, Hon. Shirley Ayorkor Botchwey, former Ghanaian Minister for Foreign Affairs and Regional Integration, officially took office as Secretary-General of the Commonwealth. She succeeds Patricia Scotland, whose nine-year term concluded in March. Botchwey makes history as the first African woman—and only the second African ever—to lead the 56-nation association, which represents over a third of the global population and more than a quarter of United Nations member states.

#### She said

"The world we woke up to today is unlike any we have seen in our lifetimes. The consequences of lower economic growth, increased defence expenditures, and a frayed multilateralism will affect our pockets directly, increase unemployment and poverty, reduce social protection and weaken our resilience to shocks.

"The value of our Commonwealth stands in bold relief, in a time like this. For over 75 years, the Commonwealth has been a unique and powerful force for good. Now we must seize the moment to realise the transformation our societies seek."

# UN TREATY ON OLDER PEOPLE'S RIGHTS GAINS MOMENTUM

(A New International Agreement Could Boost Protections for One of the World's Most At-Risk Populations )

The United Nations Human Rights Council on April 3, 2025, began an intergovernmental process to draft an international human rights treaty on older people. The consensus resolution is an important victory for human rights and multilateralism at a moment of increasing international uncertainty.

Older people around the world experience a wide range of human rights violations on a daily basis. They include violence and mistreatment; age-based discrimination; social, economic, and political exclusion; denial of access to care and support services; inadequate social security; exclusion from climate change responses; and abuses in armed conflict.

# ACCELERATING POSITIVE HEALTH OUTCOMES IN THE COMMONWEALTH

(The Commonwealth Advisory Committee on Health (CACH) Meeting)



The Commonwealth Advisory Committee on Health (CACH) convened to discuss the key meeting health outcomes for the upcoming Commonwealth Health Ministers Meeting in May 2025. Chaired by the Government of Kiribati, the CACH meeting included Jacqueline WM Wong, Vice Chair, CommonAge and representatives from member countries, regional bodies including ECSA-HC and CARICOM, and accredited organisations, including the Commonwealth Health Professions Alliance and CommonAge. Discussions were wide-ranging and included sustainable financing, climate resilience, non-communicable diseases - including cancers, mental health, digital innovations and healthy ageing.

Contributions to the agenda items were also made by other health professionals and policymakers from Commonwealth member states who were online. On healthy ageing, CACH engaged with Dame Carol Black, the Commonwealth Secretary-General's Special Envoy for Ageing Well, who shared key areas from her publication, Ageing Well in the Commonwealth.

Early bird registration began on May 1, 2024, with discounted rates available for IFA members, delegates from low- and middle-income countries, and students or older individuals. The conference expects over 1,200 attendees from more than 70 countries, offering a unique platform for knowledge exchange and collaboration to drive positive change for ageing populations worldwide.

#### AgeWatch Africa Foundation Hosts Workshop to Empower Retired Football Legends

Richard Waindi, founder of AgeWatch Africa and Head of our Kenya Chapter, played a key role in organising workshops held in Nairobi on December 18, 2024 and January 24, 2025. The events brought together former legendary footballers from the Nyanza and Western regions and focussed on providing practical solutions to emotional, mental and financial hurdles often faced by retired players. Through collaborations with experts and stakeholders, the workshops aimed to foster long-term support systems for these sports icons. The event was graced by legendary footballers like Bobby Ogola, Peter Dawo and key officials from Kenya Football Welfares Association (KEFWA).

The workshops included interactive sessions on personal finance management, entrepreneurship, mental health care and community leadership, tailored to meet the unique needs of retired athletes. Additionally, it served as a platform for networking, collaboration and resource-sharing among former players and industry stakeholders.

AgeWatch Africa Foundation is a non-profit organisation dedicated to improving the lives of aging populations through advocacy, education and targeted interventions. Its programmes are designed to promote wellness, financial security and mental health for individuals in their post-retirement years. The foundation is committed to supporting aging populations across Kenya, with a particular focus on athletes who often face unique challenges after their careers. #### Train the Trainer Success story - Dementia Care Training in Kenya

On April 2<sup>nd</sup>, 2025, our Kenya Chapter and Charis Eagle Springs successfully organised a Train-the-Trainer Programme on Elder Care, building on the expertise gained by Margaret Njagi (Vice Chair, Kenya Chapter) through a CommonAge-led initiative. The participants were enthusiastic and eager for more training opportunities. They expressed a strong commitment to sharing their knowledge, engaging others, and supporting the CommonAge Kenya Chapter in achieving its mission.

This training—developed in collaboration with TAFTA and led by Fulbright Scholar Dr Renu Abraham Varughese—focussed on dementia care, neurological diseases & disorders associated with old age. The Programme was designed to create a ripple effect across organisations. By empowering trainees to become trainers themselves, we're not just raising awareness—we're transforming aged care practices from within.

#### INDIA CHAPTER

#### Setting the Stage for an Age-Friendly Initiative

The CommonAge India Chapter team, Mansur Dalal, Chair; Dr Renu Varughese, Director and Head India Chapter; Jiji Philip, Vice Chair; along with Dr Praveen Pai, Chairman, CEDAC finalised the draft proposal for the first on the ground initiative to roll out a comprehensive agenda on an age friendly city with a dedicated centre and with tie ups with a local medical college and council.

The Community Ageing Resource Center (CARC) in Mundiappally is pioneering a proactive ageing model in Kerala, integrating healthcare, learning, and social participation. Partnering with Believers Church Medical College and CEDAC, it fosters independence, intergenerational collaboration, and economic engagement, aligning with WHO's healthy ageing framework to reduce hospitalisations and enhance social inclusion.

The Mundiappalli Model, developed by Believers Church Medical College, enhances community-based geriatric care. Initially focused on homecare and palliative services, it expanded in 2024 with a dedicated geriatric centre in Mundiappalli. Partnering with CEDAC and CommonAge India, the model integrates WHO's Healthy Ageing Framework, emphasizing preventive care, social inclusion, and economic participation. The Community Ageing Resource Center (CARC) now leads this effort, reducing hospitalisations and empowering seniors.

Through CommonAge's international network, the initiative will establish academic linkages fostering joint research projects, and training programs, aligning research outputs with the WHO Healthy Ageing Framework. This academic integration will not only build evidence-based age-friendly interventions but also position the Mundiappally Model as a national and global reference for community-driven geriatric care and education.

#### The Global Ageing Network

Roundtable 2: Joseph Musgrave, (CEO of Home & Community Care Ireland) moderated a thought-provoking discussion with panellists Mansur Dalal (Chair, CommonAge) and Dr Robyn Stone (Senior Vice President of Research at LeadingAge and Co-Director of the LeadingAge LTSS Center at UMass Boston). The session explored the ethical dimensions of recruiting and supporting foreign-born healthcare workers, as the global shortage of health human resources reaches a critical tipping point.

The discussion centred around: - Strategies used by countries to attract foreign-born workers, the impact of these programmes on countries of origin and how global collaboration can ensure ethical and sustainable workforce solutions.
